Growing Up Green Charter School II, the surviving education corporation, will continue to administer the educational operations and purposes of the constituent corporations in the same manner as they presently exist, and the provisional charter of Growing Up Green Charter School II, the surviving education corporation, is amended to change the name of the surviving education corporation to “Growing Up Green Charter Schools” and to revise the purposes of such corporation to read as follows:

a) To operate two charter schools (2):

1. Growing Up Green Charter School; and
2. Growing Up Green Charter School II.

up through and including June 30, 2025, pursuant to Article 56 of the Education Law and in accordance with the applicable charter agreement between such corporation and the Board of Regents and any subsequent authorized extensions, revisions or amendments thereto.

b) To operate such additional charter school(s) as it shall be authorized to operate pursuant to Article 56 of the Education Law and in accordance with the respective charter agreement(s) for such school(s) between such corporation and the Board of Regents, and any subsequent authorized extensions, revisions or amendments thereto.


3. The separate existence of the constituent education corporations Growing Up Green Charter School and Growing Up Green Charter School II hereby ceases and the surviving education corporation, Growing Up Green Charter School II under the amended corporate name “Growing Up Green Charter Schools” is hereby vested with all the rights, privileges, immunities, powers and authority possessed or granted by law to the constituent corporations. All assets and liabilities of the constituent corporations are hereby assets and liabilities of such surviving education corporation. All property, real, personal and mixed and all debts to the constituent corporations on whatever account are hereby attached to Growing Up Green Charter School II, the surviving education corporation under the amended corporate name “Growing Up Green Charter Schools,” and may be enforced against it to the same extent as if the debts, liabilities and duties had been incurred or contracted by it.


4. The consolidated corporation shall operate under the provisional charter granted to the surviving education corporation, Growing Up Green Charter School II under the amended corporate name "Growing Up Green Charter Schools," and any subsequent authorized extensions, revisions or amendments thereto.

The merger herein shall take effect on July 1, 2022.
