<b>Code 15</b> <i>Professional Salaries</i>	<p><i>Title I, Part A will be used to partially cover the salaries of two Learning Specialists who will provide small group instruction for at-risk students within a tiered Response to Intervention program.</i></p> <p><i>Learning Specialist: 0.35 FTE = \$34,019</i>  <i>Learning Specialist: 0.35 FTE = \$24,171</i></p> <p><i>The Math Coordinator will provide interventions and remedial instruction in Math for students at risk for academic failure.</i></p> <p><i>Math Coordinator: 0.338 FTE = \$30,833</i></p> <p><i>Specifically, the Coordinator will:</i></p> <ul style="list-style-type: none"> <li><i>• Provide one-on-one and small group remediation to students in the Kindergarten through 4<sup>th</sup> grades</i></li> <li><i>• Provide effective math instructional strategies to assist teachers in differentiating instruction for students below grade level</i></li> <li><i>• Coordinate assessments and produce data reports for teachers to utilize when identifying students in need of additional support and for measuring achievement growth of students receiving targeted interventions.</i></li> </ul> <p><i>For the school's homeless reserve, Title I, Part A will partially cover the salary of the Director of Counseling, who serves as the homeless liaison (0.025 FTE = \$1,500) As the homeless liaison, the Director of Counseling ensures that all homeless students are identified and provided with the services required. If needed, additional Title I will be utilized to provide necessary services.</i></p> <p><i>Total = \$90,523</i></p>
